4.1 Workforce Innovation and Opportunity Act (WIOA)

Discussion; WIOA approved by congress in July. Awaiting rules and regulations due to be out mid-late January. Essentially it's an alignment of Workforce Development and the Dept. of Education and Economic Development working together, looking more at developing individuals for career rather than just a job. They are looking for more business members on the RWIB board. There are also some performance changes, such as length of time they are looking at measurements of performance levels, etc. Includes vocational rehabilitation. Also, youth funding has been at 30% and will be moving up to 75%.

Mayor Erb: Took part in conference call by Workforce Development office in Des Moines regarding proposed changes to regional lines, as demonstrated on maps distributed. There will be an in-person meeting in Des Moines in December, which Mayor Erb will attend. A letter of support of the existing arrangement has been prepared for Mayor Erb's and Jay Urdahl's signatures, in which the RWIB and CEO chairs request to keep the current region arrangement AS-IS.
